My comment: To the Board of the Rocky Flats Stewardship Council,

The Feb 20th 2024 meeting of the RFSC subcommittee revealed all the fraudulence these proceedings have been corrupted by under the direction of David Ableson. A massive government failure is again to be made public by Mr. Abelson's comment that the board should not risk over-thinking the exercise of decommissioning the meeting or replacing it with a new structure and new powers. What is placed in harm's way by proceeding jauntily and foolishly in the direction of simply disbanding? Probably nothing. Still, David poses this problem to the council while stepping back in precisely the way a jilted keeper does. While it is important to remember that David has only played the role of inaction, arguing that arguing itself would be a better use of public monies than further remediation. He has never explored the infinite possibilities of reducing the risk of exposure to residents who live within the jurisdictions the Stewardship Council holds sway. Every form of biological life is affected by the inaction of the Rocky Flats Stewardship Council, every toad, and snail, every blade of grass and pinecone are contained in a state of continual exposure that (we presume) remains relatively constant since the closure of the site. The Oct 31 2021 letter by Jon Lipsky describes the crazy calculus by which exceedances revealed in one month are called non-actionable by a reduction in a 12 month average in the following year. What happened to the 60 day window in which reportable conditions have to be addressed. Jon Lipsky is pointing to more than one or another .9 picoCuries in a .15 picoCurie RFLMA standard, his letter describes a familiar pattern of doublespeak and rhetoric that does not aim to answer in good faith the concerns of the public or other board members directly. Former Agent Lipsky's letters, three of them written between Oct 30th and November 1st of 2021 are no longer accessible on this website (www.rockyflatssc.org).

As conditions go, it appears to me that doing well has always meant doing nothing to Mr. Ableson. But to a fragile community who aims to live in harmony with the environment Mr. Ableson's commitment to inaction is unacceptable. Stewardship Council meetings can meet at a more rational time and greater transparency can exist in this publicly funded legislative body. Similarly, the Rocky Flats Stewardship Council under Mr. Ableson's direction has ill equipped

residents for the unsuitable conditions for health on the Colorado Front Range, and the absolute cost of this neglect may be incalculable. Thank you for your assistance in reimagining this organization.
